# LEAGUE OFFICERS TOURNAMENT

## RULES

**ELIGIBILITY:** Participation is limited to include all USBC-BA, USBC-WBA, and YABA Associations officials and every league officer who holds a valid Monmouth County certified summer or winter membership card for the current season. Eligibility includes all life members, delegates and Sergeant-at-Arms. A league Team Captain by definition is not eligible unless he or she is also a league line officer. In addition, the participant must have a 21 game average. Those eligible to cash will be limited to those officials whose names were registered with either local association by the closing date.

**SUBSTITUTES:** A substitute must meet eligibility requirements. No substitute will be permitted after a participant has started competition unless the original player cannot continue to bowl.

**FORMAT:** This is a pins over average tournament, whereby each team will bowl three games on the same pair of lanes. The combined averages of the two players are totaled and the number of pins over average of each team game is recorded as a plus total, and the pins under average as a minus total. The winners will be decided by the highest actual total pinfall of a team with above the teams entering average.

**TEAM ENTRY:** Any two eligible officers may join together as a doubles team. There is no restriction on any combination of eligible team partners, whether or not they are from the same league or one is a County official from any of the local associations, all men, all women, or mixed. There is no combination that cannot enter. Different partners may participate one time on each squad.

**AVERAGES:** Will be based on the following (A), (B), and (C) definitions:

- (A) A bowler will use the highest previous season's average based on a minimum of 21 games, either Winter 2006-2007 or Summer 2007.
- (B) A bowler who does not have a previous season average shall be accepted on the basis of the highest 21 or more games average of the current regular season at the time of entry mailing. A WRITTEN VERIFICATION OF CURRENT AVERAGE AS OF MAILING DATE MUST BE SUBMITTED WITH THIS APPLICATION.
- (C) If neither of the above exists, a 2007 summer league average based on the highest 21 or more game average may be used. A WRITTEN VERIFICATION OF THE SUMMER AVERAGE MUST BE SUBMITTED WITH THIS APPLICATION

If a submitted average is lower than any verifiable true average, resulting in a greater number of pins over average, the score(s) shall be disqualified, USBC Rule 319a (3).

USBC Rules 319a (2), 319c, 319d, and 319e will not apply as they refer to adjusting an average, or the listing of prior prize winnings.

### **NOTICE WHEN TO BOWL:**

Will only be sent to the team captain immediately after the closing date if DIFFERENT from the squad time requested.

Check in one-half hour before scheduled squad to bowl and present certification card to Tournament officials for lane assignment.
