## TOURNAMENT RULES

1. All games bowled in the 2009 Paul Albrecht Sr. Open Tournament are subject to the rules of the United States Bowling Congress. The tournament management reserves the right to reject or re-rate any entrant.
2. All bowlers, 50 years of age or older, who are members of Monmouth County USBC for the 2009-2010 season are eligible to compete.
3. This is a Handicap Doubles, Singles and All Events tournament.
4. Handicap is 100 per cent of difference between average and 230 scratch in Singles and All Events, and 460 scratch in Doubles event. There is no limit on the amount of handicap.
5. There are three classes of competition: Division 1 – age 70 and older; Division 2 – 60 to 69 years of age, inclusive; Division 3 – 50 to 59, inclusive. Age at time of bowling first event determines classification. Entrants must verify age when checking in to bowl.
6. Age classifications are used for singles and all events. Doubles partners do not have to be from the same age group since there is only one class of competition in doubles.
7. Entrants are eligible to compete only once in singles event. However, entrants may bowl only in singles or in doubles. Only the first entry counts toward the All Events total (USBC Rule 315). Reentry applications must be submitted up to one hour before bowling starts.
8. Averages are used in the following order (based on a minimum of 21 games in a Monmouth County certified league):
  - (A) 2008-09 season in Monmouth County.
  - (B) Current season as of November 5, 2009, based on a minimum of 21 games. Written verification by League Secretary required. All others bowl scratch.
9. Entries Close on Thursday, November 5, 2009.
10. It is each bowler's responsibility to verify the accuracy of his/her average. Failure to use proper average shall disqualify score if submitted average is lower than actual, thereby resulting in more handicap. Prize winnings are based on the average submitted. If it is higher than the actual average. In the case of a doubles team, the average is combined to determine whether the correct total is higher or lower than the total submitted. Corrections in average may be made before completion of the second game of the first series bowled.
11. Any entrant who must have his/her average adjusted under the provisions of USBC rule 319E must report such adjusted average prior to bowling.
12. The 15-pin increase rule for current average as of November 8, 2009 based on 21 games (USBC Rule 319a2) and reporting of prize winnings (USBC rule 319d) applies.
13. The entrance fee is \$23 per bowler, per event. Prize - \$11.00; Bowling fee - \$9.00; Expenses - \$2.00; Optional All Events - \$3.00; Youth Support - \$1.00.
14. The prize ratio is 1 in 5 in each event, Doubles, Singles and All Events.
15. Entrants who are ages 50-54 are not eligible for any USBC Senior Awards and are not eligible to participate in the USBC National Seniors Tournament.
