There will be side-pots offered that include: Brackets (Games 1-2-3), High Game & High Series Pot (Games 1-2-3) and Eliminator (Games 3-4-5).

QUALIFYING: This tournament will be conducted on an elimination basis through one qualifying round of 5 games and a final round of match play. Each entrant shall bowl one block of 5 games across 5 lanes with each player moving to the right after each game to an assigned lane. On the basis of total pinfall for 5 games, the top 16 will move to the finals for match play.

FINALS: The top 16 players from the qualifying round shall enter the final round of competition. Final round competition will be match game play conducted under a single elimination method. Each match shall be over 2 games. Total pins decide the winner. Pairings for the initial match will be seeded according to total pinfall of the 5 games, (e.g., No.1 vs. No. 16; No. 2 vs. No. 15, etc). After the initial match, pairings and lane assignments will be in accordance with a normal bracket system which will be displayed at the tournament site.

TIES: For qualifying and finals, the tied players shall bowl a one ball roll-off until the tie is broken.
