1. To be eligible, all bowlers must have membership in USBC through Monmouth, Ocean or Middlesex County.
2. Entrants will abide by the rules of the USBC. USBC rules 319a, 319d, and 319e do not apply
3. Qualifying rounds – will consist of 5 games bowled across 5 pairs of lanes. Semi-finals will consist of at least 1/3 of the highest bowlers from the qualifying rounds who will roll 3 games across 3 pairs of lanes.
4. The tournament will be conducted on a scratch basis. Total pinfall will be carried into the Semi-finals. The final round will be head to head competition.
5. Final Round – top 5 qualifiers will bowl a one game elimination match. Number 5 matched with number 4, with the winner meeting number 3, etc.
6. Ties – In the event of a tie for last place after the qualifying round, they will both advance to the semi-finals round. If there is a tie for last place after the semi-finals round, there will be a one game roll-off to determine the last qualifying position. In the event of a tie for any of the first five positions of the finals, a sudden death two frame roll-off will be bowled on the same lane each contestant finished her game. If the championship match is tied, a complete game must be bowled to determine the Queen.
7. For qualifying and semi-final rounds, all players will be allowed five minutes of practice on the starting pair of lanes only. For the final round matches, each player will be allowed two practice deliveries on each lane used in the match.
8. All entrants must report to the lanes one half hour prior to scheduled time. A player arriving late will begin play and her score will count beginning in the frame then being bowled. Entrants are requested to wear proper attire.
9. High game to be awarded to whoever earns it and has **NOT** qualified for the semi-finals or final rounds.
10. Entry fee cannot be transferred. Entry fee is not refundable after June 20, 2008.
11. The decision of the Tournament Committee shall be final unless an appeal is made in accordance with USBC rule #329.
