1. **Eligibility:** All individual adult male and females who are members of the USBC for 2009-2010 season may bowl in this tournament. Unmarried grade and high school students who wish to bowl in the tournament, who have not attained the age of 18, must have a legal consent form from their parent or legal guardian who must be present to sign. All bowlers must have a current USBC membership card when checking in.
2. **Averages:** Individuals must use their highest 2008-2009 USBC book average for 21 games. If no 2008-2009 book average, use highest current average for at least 21 games as of April 1, 2010 (bring league sheet for verification). If you do not meet either of these requirements, you must bowl using a 230 average. All bowlers are responsible to verify his/her average. If the submitted average is lower and results in more handicap, the bowler's score will be disqualified. Falsification of average will result in disqualification. The 10 Pin rule is not in affect for this tournament.
3. **Check-in:** All bowlers should report to check in desk one hour before scheduled to compete.
4. **Entry Limit:** A bowler may bowl in this tournament in all 4 events, but can only qualify once to bowl in the finals.
5. **Payments:** Payment can be made in advance or at tournament site on the day of the tournament by cash or check. Any payments made by check are subject to a \$35.00 returned check fee. Make checks or money orders payable to Gotta Have It Bowling Club.
6. **Prizes and Handicaps:** Handicap will be based on 90% of 230. Prize money will be distributed 3 days following the commencement of the tournament.
7. **Format:** Each bowler will bowl two 4 game blocks with a 45 minute break between sets. The top ten from each qualifying house will move on to the finals on May 2, 2010 at Majestic Lanes. The top 20 bowlers that advance to those finals, will bowl a 3 game set. The field will then be cut in half. Top ten will bowl 2 games of Match Play, winner receiving 30 bonus pins. The top 5 total pin fall (with bonus) will advance to a stepladder format (5 vs 4, winner vs 3, and so on). In event of a tie at the end of Match Play for the top 5 spots, a one game rolloff will determine their places. In the event of a tie in the Stepladder, bowlers will bowl the 8,9,& 10th frame as the tiebreaker.
8. **Optional Singles:** There will be an optional scratch singles event within this Tournament for an additional \$20.00. It will have a separate prize list relative to the number of entries. Optional singles will be run for all 4 qualification events and results will be combined into one tournament within a tournament. Participants in the optional scratch singles event can only cash one time, highest placement will be awarded.
9. **Appeals and Protests:** Any appeals or protests must be made in writing and submitted no later than 24 hours after the game has been bowled. The appeal of protest shall briefly state the grounds for the appeal or protest. The action of the board of directors on this appeal shall be final pending an appeal to USBC.
